Copyright License

This License does not authorize You to speak on behalf of BCCDC Foundation, including in relation to the Content. You will direct any inquiries relating to the Content to BCCDC Foundation.

5. Term and Termination

This License applies for the term of Copyright in the Content licensed herein, unless terminated as provided herein.
